

RESOLUTION NO. 2009 - 358

A RESOLUTION MAKING CERTAIN CHANGES IN THE BUDGET OF THE CITY OF TAMPA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2009; APPROVING THE TRANSFER, REALLOCATION AND/OR APPROPRIATION OF \$270,000 WITHIN THE WASTEWATER STATE LOAN CONSTRUCTION FUND FOR THE AWARD OF CONTRACT 08-C-35, MORRISON AVENUE PUMPING STATION REHABILITATION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, additional revenue or unappropriated surplus, or funds previously appropriated which are no longer needed for their original purpose, are available for transfer, reallocation and/or appropriation to accounts within the Wastewater State Loan Construction Fund, and such transfer, reallocation and/or appropriation is for a necessary municipal purpose;

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TAMPA, FLORIDA, THAT:

Section 1. The transfer, reallocation and/or appropriation of the sum of \$270,000 within the Wastewater State Loan Construction Fund, as set forth below, is hereby approved.


