

RESOLUTION NO. 2009- 360

A RESOLUTION MAKING CERTAIN CHANGES IN THE BUDGET OF THE CITY OF TAMPA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2009; APPROVING THE TRANSFER, REALLOCATION, AND APPROPRIATION OF \$169,033 WITHIN THE STORMWATER OPERATING CAPITAL FUND FOR CONTRACT 09-C-00015, 113TH AVENUE STORMWATER POND SEDIMENT REMOVAL PROJECT; PROVIDING AN EFFECTIVE DATE.

WHEREAS, certain funds previously appropriated in the Stormwater Operating Capital Fund for the fiscal year ending September 30, 2009, will not be needed for the purpose for which appropriated, and the transfer of said funds to other accounts within said Fund as set forth herein is for a necessary municipal purpose;




