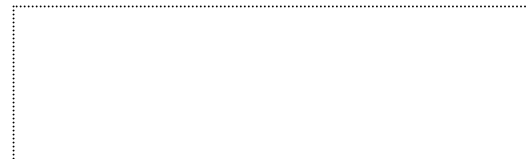

Just wanted to make you aware of upcoming public workshops that you may wish to attend and offer your comments to City Council.

City Council Workshop

May 28, 2009 at 11:00 a.m.

- To discuss January 2009 Cycle of Chapter 27 Zoning Code Text Amendments.

July 23, 2009 at 10:00 a.m.

- To discuss the draft Transportation Technical Manual of Minimum Standards.

August 27, 2009 at 9:00 a.m.

- To discuss cell phone tower regulations, which are as follows: a) notice (posting of signs and mailing notices), b) setbacks and fall zones, c) public hearings being held before Council, d) buffering, e) treating applications to place a cell tower on public property the same as private property, and f) fire stations.

City Council public hearings/workshops are located in the City Council Chambers, 315 E. Kennedy Blvd. 3rd Floor.

Green Idea:

Tampa's water use restrictions changed on April 3, 2009. Locations inside and outside the City limits using City of Tampa-provided public supply water for irrigation are limited to hand watering or the use of micro-irrigation. Locations utilizing well water or other alternative water resources follow different water use restrictions.
