Just wanted to make you aware of upcoming public workshops that you may wish to attend and offer your comments to City Council.

City Council Workshop

July 23, 2009 at 10:00 a.m.

- To discuss the draft Transportation Technical Manual of Minimum Standards.

August 27, 2009 at 9:00 a.m.

- To discuss cell phone tower regulations, which are as follows: a) notice (posting of signs and mailing notices), b) setbacks and fall zones, c) public hearings being held before Council, d) buffering, e) treating applications to place a cell tower on public property the same as private property, and f) fire stations.

August 27, 2009 at 9:30 a.m.

- To discuss having a requirement for accurate representations of building elevations to be submitted as part of the site plan zoning district.

City Council public hearings/workshops are located in the City Council Chambers, 315 E. Kennedy Blvd. 3rd Floor.
