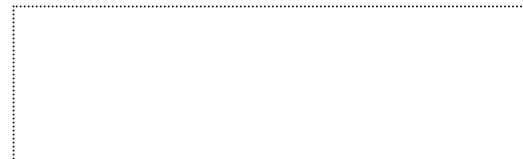

Dear Neighbors,

Just wanted to make you aware of upcoming public workshops that you may wish to attend and offer your comments to City Council.

City Council Workshop

May 28, 2009 at the a.m. hearing

- To discuss January 2009 Cycle of Chapter 27 Zoning Code Text Amendments.

July 23, 2009 at 10:00 a.m.

- To discuss the draft Transportation Technical Manual of Minimum Standards.

August 27, 2009 at 9:00 a.m.

- To discuss cell phone tower regulations, which are as follows: a) notice (posting of signs and mailing notices), b) setbacks and fall zones, c) public hearings being held before Council, d) buffering, e) treating applications to place a cell tower on public property the same as private property, and f) fire stations.

City Council public hearings/workshops are located in the City Council Chambers, 315 E. Kennedy Blvd. 3rd Floor.

Green Idea:

Consider installing or converting to a micro irrigation system. **MICRO IRRIGATION**, the application of water at a slow rate, is a more efficient way to irrigate trees, shrubs and ground covers. Benefits of micro irrigation include:

- A better soil water / oxygen balance is achieved, resulting in faster growth and less plant loss.
- Foliage and flowers are not wetted, resulting reduction of plant disease and longer lasting blooms.
- Weed growth is reduced, as very little soil surface is wetted.

Existing in-ground sprinkler systems can be easily modified. Use retrofit kits available at garden centers and home improvement stores to convert spray heads to micro irrigation.
