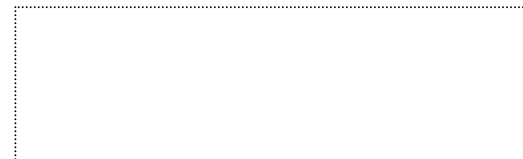

City Council has rescinded the continuance of this item from November 16, 2006 at 5:01 p.m. to April 12, 2007 at 5:01 p.m. and has rescheduled it to March 1, 2007 at 5:30 p.m.
