



Marjorie Park Yacht Basin Monthly Slip Permit Fees

- All slips with dock boxes and potable water are \$12 per foot per slips length or length of vessel; whichever is greater, minimum 40 foot on all slips except E1, which is 26 feet.
- All slips without dock boxes and water are \$10.50/ft per slip length or length of vessel, whichever is greater, minimum 30 ft on slips.
- Electricity is available at certain slips. Where provided by the City, the Parks and Recreation Department Director or his/her designee will set additional fees and deposits. Each Slip Permittee must contract other utilities from the Utility Provider.

Non-city Residents Month Slip Permit Fees

In addition to the regular permit fee as stated herein, a non-resident fee of \$1.00 per foot of the regular permit fee will be added for individuals who live outside the City of Tampa limits.

Tampa Convention Center Transient Boating Facility Slip Permit Fee

The owner or operator of any transient vessel berthed at this facility will be charged:

- Short Term: \$2.00 per hour for the first 10 hours
- Long Term: \$1.00 per foot vessel after 10 hours and up to 24 hours with a minimum charge of \$25.00 and a maximum stay of 72 hours.
- Electricity is available at certain slips. Where provided by the City, the Parks and Recreation Department Director or his/her designee will set additional fees and deposits. Each Slip Permittee must contract other utilities from the Utility Provider.

Transient Vessels Slip Permit Fee

The owner or operator of any transient vessel berthed at any marina except the Tampa Convention Center Boating Facility shall be charge \$2.00 per foot per slip length or length of vessel, whichever is great per day.

Special Event Transient Slip Permit Fee

- During special events as defined by the Parks and Recreation Director, this fee will supercede the normal transient dock permit fees.
- The owner or operator of any transient vessel berthed at any of the marinas will be charged \$4.00 per foot per slip length of length of vessel whichever is greater per day for any such transient vessel.

- An additional \$5.00 for 30 amps or \$10.00 for 50 amps per day shall be charged for vessels using the Marjorie Park transient slips.
- A one time non-refundable administrative fee of \$25.00 is required to be placed on the special events slip permit waiting list.

Slip Security Deposit

All tenants require a slip security deposit equal to one-month permit fee when the initial slip permit is issued.

Delinquent Accounts

Accounts will be considered delinquent as defined in Chapter 16 of the Tampa City's Code of Ordinances. Any delinquent account shall be charged a \$25.00 initial late fee and \$5.00 each additional day delinquent.

Marina Slip Waiting Fee

- A one-time fee of \$100.00 is required to be placed on the waiting list or maintained on the current waiting list. \$25.00 will be applied to a non-refundable administrative fee and \$75.00 will be applied to the slip security deposit when the slip permit is issued.
- Removal from waiting list - The \$75.00 fee shall be refunded within 60 days upon written notice of the person wishing to be removed from the waiting list.
