

RESOLUTION NO. 2008- 414

A RESOLUTION AUTHORIZING AN AGREEMENT FOR CONSULTANT SERVICES BETWEEN THE CITY OF TAMPA AND POST, BUCKLEY, SCHUH & JERNIGAN, INC., IN THE AMOUNT OF \$1,031,490.54, FOR CERTAIN PROFESSIONAL ENGINEERING DESIGN SERVICES AND CONSTRUCTION ENGINEERING INSPECTION SERVICES PERTAINING TO CONTRACT 8-D-29, FDOT I-4 LEE ROY SELMON EXPRESSWAY CONNECTOR PROJECT FROM I-4 TO SOUTH OF SELMON EXPRESSWAY, WATER AND WASTEWATER DESIGN; AUTHORIZING THE MAYOR TO EXECUTE SAID AGREEMENT ON BEHALF OF THE CITY OF TAMPA; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Tampa (CITY) has a need for certain professional engineering design services and construction engineering inspection (CEI) services pertaining to the FDOT I-4 Lee Roy Selmon Expressway Connector Project from I-4 to South of Selmon Expressway, Water and Wastewater Design and desires to utilize the services of Post, Buckley, Schuh & Jernigan, Inc. (CONSULTANT) to provide such professional services; and

WHEREAS, CONSULTANT desires to provide such professional engineering and technical services and is willing and able to undertake the work in accordance with this Agreement; and

WHEREAS, the selection of this firm was in compliance with the Requirements of the "Consultants Competitive Negotiations Act"; and

WHEREAS, compensation for services shall be not exceed \$1,031,490.54 as described in Section V of this Agreement and funds for payment of said services are available in the appropriate accounts in the Budget of the City of Tampa.

NOW, THEREFORE

BE IT RESOLVED BY THE CITY COUNCIL
OF THE CITY OF TAMPA, FLORIDA:

Section 1. That the Agreement between the City of Tampa, Florida and Post, Buckley, Schuh & Jernigan, Inc., for provision of professional engineering design services and construction engineering inspection services pertaining to Contract 8-D-29, FDOT I-4 Lee Roy Selmon Expressway Connector Project from I-4 to South of Selmon Expressway, Water and Wastewater Design, a copy of which is attached hereto and made a part hereof, is approved and authorized in its entirety or in substantially similar form.

Section 2. That the Mayor of the City of Tampa is authorized and empowered to execute, and the City Clerk to attest and affix the official seal of the City of Tampa to, said Agreement on behalf of the City of Tampa.

Section 3. That funds for payment of services to be provided under said Agreement in the amount of \$1,031,490.54 shall be available in the Budget of the City of Tampa for the Fiscal Year ending September 30, 2008, in Account No. SS0342BJD-06305, \$342,305.55; Account No. WT0443BAH-06305, \$149,719.65; and Account No. WT0443BAI-06305, \$539,465.34.

Section 4. That other proper officers of the City of Tampa are hereby authorized to do all things necessary and proper in order to carry out and make effective the provisions of this Resolution, which shall take effect immediately upon its adoption.
