**A RESOLUTION APPROVING AN AGREEMENT BETWEEN THE CITY OF TAMPA AND CH2M HILL CONSTRUCTORS, INC. FOR DESIGN BUILD SERVICES IN THE AMOUNT OF \$6,661,253.00 IN CONNECTION WITH CONTRACT 6-C-73, UTILITY CAPITAL IMPROVEMENTS PROJECTS, AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT; PROVIDING FOR THE FUNDING THEREOF; AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, in accordance with the Consultants' Competitive Negotiations Act, the City has made a selection and desires to enter into an Agreement with CH2M HILL Constructors, Inc., for professional Design Build Services in connection with Contract 6-C-73, Utility Capital Improvements Projects which requires City Council approval.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TAMPA, FLORIDA, THAT:

Section 1. The Agreement between the City of Tampa and CH2M HILL Constructors, Inc., for professional Design Build Services in connection with Contract 6-C-73, Utility Capital Improvements Projects, a copy of which is attached hereto is hereby approved in its entirety or in substantially similar form.


Section 2. The Mayor is authorized to execute and the City Clerk to attest and to affix the official seal to the Agreement for and on behalf of the City of Tampa.

Section 3. Payment of the costs of the services rendered in connection with the Agreement, in the amount of \$6,661,253.00, shall be made from funds provided in the budget of the City of Tampa for the Fiscal Year ending September 30, 2008, in Account No. SS0342VAN-06306, \$460,957.00; SS0342VAN-06305, \$285,886.00; SS0442VJL-06306, \$58,570.00; SS0442VJL-06305, \$69,321.00; WT0443VAA-06306, \$1,480,473.00 and WT0443VAA-06305, \$4,306,046.00.

Section 4. The proper officers of the City of Tampa are hereby authorized to do all things necessary in order to carry out the provisions of this Resolution, which shall take effect immediately upon its adoption.
