RESOLUTION NO. 2007- 1067

A RESOLUTION APPROVING AN AGREEMENT FOR CONSTRUCTION MANAGEMENT SERVICES, IN THE AMOUNT OF \$1,039,661.00, BETWEEN THE CITY OF TAMPA AND SKANSKA USA BUILDING, INC. IN CONNECTION WITH THE CURTIS HIXON WATERFRONT PARK, TAMPA MUSEUM OF ARTS, AND KILEY GARDEN REPAIRS, CONTRACT 7-C-16; AUTHORIZING THE MAYOR OF THE CITY OF TAMPA TO EXECUTE SAME; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, via the competitive selection process in accordance with Florida Statutes Section 287.055, Consultants' Competitive Negotiation Act and consistent with Federal procurement policies, the City of Tampa (CITY) selected Skanska USA Building, Inc. (FIRM) to provide Construction Management Services in connection with Contract 7-C-16, Curtis Hixon Waterfront Park, Tampa Museum of Arts, and Kiley Garden Repairs, (PROJECT) as detailed in the Agreement for Construction Services (AGREEMENT); and

WHEREAS, the CITY desires to enter into an agreement with FIRM to provide certain preconstruction services; and

WHEREAS, it is in the best interest of the City of Tampa to enter into this AGREEMENT.

NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TAMPA, FLORIDA:

Section 1. That the Agreement for Construction Management Services between the City of Tampa and Skanska USA Building, Inc. in connection with Contract 7-C-16, Curtis Hixon Waterfront Park, Tampa Museum of Arts, and Kiley Garden Repairs, as detailed in said AGREEMENT, a copy of which is attached hereto and made part hereof, is authorized and approved in its entirety or in substantially similar form.

Section 2. That the Mayor of the City of Tampa is authorized and empowered to execute, and the City Clerk to attest and affix the official seal of the City of Tampa to, said AGREEMENT on behalf of the City of Tampa.



That funds in the amount of \$1,039,661.00 for these services are available for the PROJECT in the Budget of the City of Tampa for the Fiscal Year ending September 30, 2008, Account No. TM50353BF-06200, \$394,830.50; Account No. PK0541MAV-06300, \$368,449.15; Account No. TF506T3AW-06300, \$276,381.35.

Section 4. That other proper officers of the City of Tampa are authorized to do all things necessary and proper in order to carry out and make effective the provisions of this Resolution, which shall take effect immediately upon its adoption.
