RFQ- 7-D-40 - The City of Tampa desires to obtain Professional Roadway Engineering and Landscape Architectural services associated with the development of the **Kennedy Blvd. Corridor Pedestrian Improvement Project** from Memorial Blvd. to Woodlyn Ave and from the Draw Bridge to Channelside Drive.

Services may include but not be limited to: engineering review of the Hillsborough County Metropolitan Planning Organization's 2003 Kennedy Blvd. Corridor Study; pedestrian and transit improvements, roadway features; landscape; irrigation; surveying; design; permitting; preparation of construction documents for the enhancement; any applicable drainage; traffic engineering; coordination with adjacent utilities; coordination and compliance with FDOT and other governmental agencies; or any related activities. The preliminary engineering project is estimated at \$150,000.

A Pre-Submission Conference for this project will be conducted at 3:00PM Tuesday February 27, at 306 E. Jackson Street, Tampa, Florida, in the 4th Floor Conference Room. Attendance is not mandatory.
