Please Read Carefully As This Contains Important Information About Your Cleanup/Damage Security Deposit

It is the responsibility of the person paying for the permit to request the return of the deposit, in writing, via U.S. Mail, to: **Shelter Office, Parks and Recreation Department, 3402 W. Columbus Dr., Tampa, FL 33607** Please note it takes four to six (4-6) weeks to receive your refund after the written request has been made. See stipulations below:

- The Full Amount of the Deposit will be returned to the payee only if no damages nor additional cleanup charges apply.
- The Full Amount of the Deposit will NOT be returned to the payee if damages or additional cleanup charges apply within the range of the deposit.
- If clean-up/damage costs to the city exceed the deposit amount, the person requesting the permit shall be billed for the excess
