**BID OPENING:** 1:30PM, Tuesday, August 16, 2022 **ESTIMATE:** \$4,710,000 **SCOPE:** The rehabilitation of approximately 62,710 linear feet of 8-inch diameter, 1,180 linear feet of 10-inch diameter, 680 linear feet of 12-inch diameter, 2,675 linear feet of 15-inch diameter, 5,170 linear feet of 21-inch diameter and 1,740 linear feet of 24-inch diameter gravity sewers with a cured-in-place pipe liner and rehabilitation of 364 manholes including detuberculation, cleaning and inspection, sewage bypass pumping, re-establishing service connections, maintenance of traffic, lateral grouting, manhole rehabilitation, surface restoration.
