Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

- Item 1: SP-15 Contractor's Field Office: In the first sentence, Delete "on Page G-14"
- Item 2: SP-68 Water, Light and Power: Change the first sentence to read "Delete Article G-7.01 Water and G-7.02 Light and Power from GENERAL PROVISIONS."
- Item 3: Section 106 – Biological Filter Odor Control System, 106.02 Products, 2.1.6. Biological Media - Add the following:

The media volumes are as follows:

- Approximately 800-900 Cubic Feet of Media in total.
- Tank No. 1 ~ 10,000 lb of Sulfa-Treat Media
- Tank No. 2 ~ 12,000 lb of Sulfa-Treat Media
- Tank No. 3 ~ 1,200 lb of Carbon Media

All existing odor control media (Sulfa-Treat and Carbon) shall be removed and delivered to the Howard F. Curren Advanced Wastewater Treatment Plant. The City will dispose of the media.
