Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

Item 1: Delete S-22.01 Grades and Drainage at Street Intersection in its entirety.

Item 2: Under C1.00 General, page CI-2, replace the first sentence of the last paragraph with: "Following final payment by the City, the Contractor shall maintain, to the satisfaction of the Engineer, the surface of the unpaved trenches, shrubbery, fences, sod, and other surfaces disturbed for a period of one (1) month thereafter. In addition, the Contractor shall maintain, to the satisfaction of the Engineer, the repaved areas, curbs, gutters and sidewalks, trees, if replaced by contractor, for one (1) year after acceptance."
