Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

Item 1: Electrical Clarification; Plan Sheet No. 3, General Notes: add the following note:

ELECTRICAL

Electrical work is limited to disconnecting and re-connecting electrical facilities in order to perform the work described in the Specifications and Plans. The Engineer considers this electrical work incidental to the mechanical work and therefore limited electrical information is provided in the Contract Documents. All conduits and wires demolished during construction shall be replaced in kind and reconnected as required to provide a system that functions the same as prior to demolition. The extent of conduit and wire replacement will lie in the general vicinity of the pumping station. Aluminum or stainless steel NEMA 4X boxes shall be provided, where necessary, to facilitate splicing of the new conductors to feeder/source conductors. Contractor shall submit for approval, shop drawings and cut sheets for all proposed electrical equipment. All electrical work shall be performed pursuant to the latest National Electrical Code (NEC) by a licensed Electrician.
