Contract 14-C-00007; San Carlos Flume Replacement

Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

Item 1: Clarification: On Sheet 6, the reference to "6' and 8' chl" in the plan view on the south side of San Carlos at Lot 23 should read "6' wood fence and 5' chain link". If both fences are removed, only the wood fence needs to be replaced, as the chain link fence is to be eliminated.

Item 2: On Sheet 10, in the Box Culvert Specifications,
Delete Notes 1 and 2 and Replace with the following:

5' x 3' FDOT Index 291 Type A or B with a H20 loading and less than 2 feet of earth cover.

Item 3: Flow in Flume During Rain Events:

Models show the peak flow during the mean annual storm event is 140 cfs.

Item 4: Attached for reference is the pre-bid meeting sign-in sheet.
