Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

- Item 1: Replace plan sheet E23 with the attached plan sheet E23.
- Item 2: Delete Workmanship and Materials Section 50 in its entirety.
- Item 3: Attached is a copy of the pre-bid meeting sign-in sheet.
- Item 4. Maintenance Of Traffic clarification: The service road near the pumpstation will need to be closed in order to construct project. The alternate south access will need to remain open.
- Item 5. Temporary Power Clarification: Per SP-67 Interruption of Service, the Contractor shall make provisions and pay for temporary power used by him in performing this work. See the following table for the electric bill information for the existing Airport Pump station from April/2015 – March/2016.

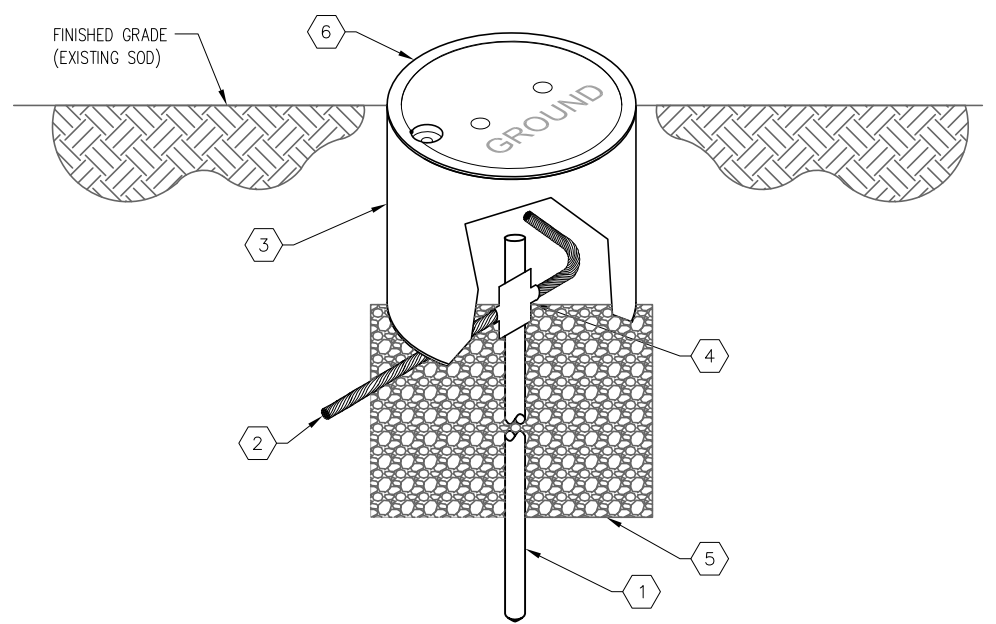

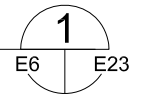
