Item 3: Add to the General Notes on plan sheet 4, the following:

G-28. AT LEAST TWO WASTEWATER PUMPS AT THE PUMPING STATION SHALL BE OPERABLE AT ALL TIMES. WORK ON THE PUMP #2 CONTROLS REPLACEMENT SHALL NOT BEGIN UNTIL PUMP #1 HAS RUN CONTINUOUSLY, AND TROUBLE FREE, FOR A MINIMUM OF SEVEN (7) CALENDAR DAYS.

G-29. PUMP ANCHORING SYSTEM SHALL BE IN ACCORDANCE WITH PUMP MANUFACTURER'S RECOMMENDATIONS. CONTRACTOR SHALL SUBMIT PUMP ANCHORING SYSTEM AND PROCEDURES FOR APPROVAL.
