Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

- Item 1: Asphalt Pathway Clarification; Plan Sheet C2.0 North Parking Lot Site Plan: A single 1.5-inch lift of Type S-3 asphalt may be installed in lieu of two (2) ¾-inch lifts of Type S-3 asphalt.
- Item 2: Stabilized Subgrade Clarification; Plan Sheet C3.0 Details and Notes: If imported material Meets LBR requirements, then further mixing is not required.
- Item 3: Staging Material Clarification: An area for staging material will be provided at the plant. Details will be discussed at the pre-construction meeting.
- Item 4: Attached for reference is the pre-bid meeting sign-in sheet.
