Contract 19-C-00004; Arc Flash Equipment Labeling at Wastewater Facilities

Bidders on the above referenced project are hereby notified that the following addendum is made to the Contract Documents. BIDS TO BE SUBMITTED SHALL CONFORM TO THIS NOTICE.

Item 1: The Bid Opening date for this project is hereby changed to February 19, 2019

Item 2: Replace Specifications Section 26 05 73.17 - Arc Flash Risk Assessment / Short Circuit / Coordination Study item 3.3 with the following:

3.3 Arc Flash Training:

The Contractor shall provide a total of sixteen (16) hours of training to the Owner's qualified electrical personnel of the potential arc flash hazards associated with working on energized equipment. The trainer shall be an authorized OSHA Outreach instructor.

The training shall provide for:

- a. Two (2) sessions of training (16 hrs/session);
- b. Each training day shall consist of eight (8) hours;
- c. Eight (8) people per session. A total of sixteen (16) employees shall be trained.
- d. At least sixteen (16) National Fire Protection NFPA 70E printed manuals shall be provided.
- 1. The training shall take place at the Howard F. Curren AWTP Maintenance Building Training Room.
- 2. The training shall include specific arc flash boundaries and distances for the equipment at the wastewater facilities designated in Attachments A1, A2 and A3.

Item 3: Clarification - The bidder must be properly Licensed by the State of Florida to conduct Contracting or Engineering and registered as a corporation with the Department of State. A bid from an electrical contracting firm is expected, but a properly Florida licensed Engineering firm may bid.

Item 4: Clarification – In Section 26 05 73.17 ARC FLASH RISK ASSESSMENT / SHORT CIRCUIT / COORDINATION STUDY, the certification called for in 1.5 A. requires that the Contractor certify that the final report and drawings have been prepared in compliance with the specifications.

Item 5: Replace the Qualifications Submittal form with the attached Qualifications Submittal form.

Item 6: Attached is the pre-bid meeting sign-in sheet.
