**CONTRACT NO.:** 23-C-00008; West Riverside Heights Gravity Sewer Rehabilitation by CIPP Lining

**BID OPENING:** 1:30PM, Tuesday, August 29, 2023 **ESTIMATE:** \$810,000 **SCOPE:** The rehabilitation of approximately 13,592 linear feet of 8-inch diameter gravity sewers with a cured-in-place pipe lining and rehabilitation of 60 manholes. Services include detuberculation, cleaning and inspection, sewage bypass pumping, re-establishing service connections, lateral grouting, manhole rehabilitation by installation of a structural coating system, elimination of active infiltration, restoration of benches, replacement of cast iron frame and cover, disposal of debris, maintenance of traffic, and surface restoration as necessary.”
