

RESOLUTION NO. 2020- 326

A RESOLUTION MAKING CERTAIN CHANGES IN THE BUDGET OF THE CITY OF TAMPA FOR THE FISCAL YEAR ENDING SEPTEMBER 30, 2020; APPROVING THE TRANSFER, REALLOCATION, AND/OR APPROPRIATION OF \$952,545 WITHIN THE GENERAL AND POLICE GRANTS FUNDS FOR USE BY THE TAMPA POLICE DEPARTMENT FOR BODY WORN CAMERA PROGRAM; PROVIDING AN EFFECTIVE DATE.

WHEREAS, additional revenue or unappropriated surplus, or funds previously appropriated which are no longer needed for their original purpose, are available for transfer, reallocation and/or appropriation to accounts within the General Fund and such transfer, reallocation and/or appropriation is for a necessary municipal purpose;

Now, Therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TAMPA, FLORIDA, THAT:

Section 1. The transfer, reallocation, and/or appropriation of the sum of \$952,545 within the General and Police Grants Funds, as set forth below, is hereby approved.


