Information on Health Benefits

We want you to know the City of Tampa employee health plan, the City's Wellness Centers, and related resources are prepared to provide you the necessary coverage for any treatment you may receive.

UnitedHealthcare Covers COVID-19 Testing

The City of Tampa UnitedHealthcare plan covers approved and authorized COVID-19 testing, and will waive member costs including copayments, coinsurance and deductibles.

UnitedHealthcare Virtual Visits-Talk with a doctor by phone or video 24/7

Virtual Visit physicians will follow established guidelines for covered members who think they may have been infected by COVID-19. Virtual Visits are available, even if you regularly treat at one of the City of Tampa Wellness Centers. ***The City will waive the \$15 patient copayment for Virtual Visits.***

BayCareAnywhere

The [BayCareAnywhere](#) program also offers 24/7 telemedicine visits, and is covered by the City's UnitedHealthcare plans. The normal primary care copay of \$30 will apply to BayCareAnywhere visits.

UnitedHealthcare/Optum Pharmacy Coverage Impacted by COVID-19

Medications are typically dispensed for 30 days or less, however those necessary for long-term use may be dispensed for 90 days. Members who need help obtaining an early prescription refill may call the customer care number on their ID card for assistance in obtaining an override. For details you may call 1-833-760-7892.

City of Tampa CareATC Wellness Centers

Both City Wellness Centers are available to assist patients for needed services, including the COVID-19 virus. There is never a patient charge when using one of the City Wellness Centers.

At this time, CareATC does not test for COVID-19. They have established the ability to manage the care of those potentially exposed to the coronavirus or who have similar symptoms. If you believe you have been exposed to or have symptoms associated with COVID-19, contact our Patient Access Center at 800.993.8244, or log in to the [CareATC Patient Website](#) from a computer or the CareATC mobile app to schedule a virtual appointment.

To protect other patients and staff, all walk-in appointments have been suspended until further notice.

Other Things You Need to Know

Watch for symptoms

Reported illnesses have ranged from mild symptoms to severe illness and death for confirmed coronavirus disease 2019 (COVID-19) cases. The following symptoms may appear 2-14 days after exposure.

- Fever
- Cough
- Shortness of breath

Practice social distancing

Keeping away from persons as much as possible can protect you and others. Try to keep a distance of 6 feet from those you are interacting with and avoid handshakes and other touching.

If you have symptoms?

Contact your primary care physician or the City Wellness Center immediately. Your physician will advise you on next steps, including whether you need to be tested. Avoid going directly to your physician so that other persons are not infected.

If you are sick with Corona Virus symptoms, stay home except to get medical care

- Stay home: People who are mildly ill with COVID-19 are able to isolate at home during their illness. You should restrict activities outside your home, except for getting medical care.
- Avoid public areas: Do not go to work, school, or other public areas.
- Avoid public transportation including ride sharing and taxis.
- Stay away from others, even within your own home.

Steps you can take in your home or workplace

- Wash your hands often with soap and water for at least 20 seconds
- If unable to wash hands use hand sanitizers with at least 60% alcohol content
- Sanitize tables and counters at home, workstations on the job, door handles and phones
- Many City worksites have hand-sanitizer stations and access to wipes. Ask your supervisor.
