

Healthy infrastructure is the foundation of a strong city -- which is why the City of Tampa is launching a Progressive Infrastructure Plan to Ensure Sustainability (PIPES).

With PIPES, the City of Tampa is investing in Tampa's tomorrow by taking a proactive approach to renew our infrastructure, prevent breakdowns, and provide long-term, permanent fixes to our water and wastewater systems.

The average residential customer, who lives inside the City of Tampa limits, will see their monthly bill change from \$41.29 to \$46.50 (does not include Solid Waste charges) in the first year. The plan to fund these projects is to gradually increase water and wastewater rates until October 2040.

The plan includes the addition of base charges to cover fixed costs during times of low water usage. The City is one of the last in the state of Florida to implement base charges. Base charges will increase as follows:

- FY20 - \$4.00 per Month per Equivalent Residential Unit (ERU); (\$2.00 each for Water and Wastewater)
- FY21 - FY34 -- Increase of \$2.00 per Month per ERU Annually (\$1.00 each for Water and Wastewater)

Customer Assistance Program

The City of Tampa will also offer a Customer Assistance Program to provide relief for qualifying account holders. This program will waive all base charges, offer a free personalized water conservation audit, and include free water saving devices.
