Keeping Your Spring Flowers Healthy

Keeping a balanced, healthy garden is not as hard as it seems. A little extra care definitely goes a long way, and will bring bountiful results soon after you start. There are a couple of things you can do to ensure that your garden is bright and full of flowers all spring and summer long.

1. Provide proper soil by laying down some compost and allowing time for soil to soak it in.
2. Space flowers and plants apart according to planting recommendations.
3. Fertilize with an organic mix, or a slow release fertilizer. Once is enough, because over-fertilizing leads to too much foliage and less flowers. Container gardens should be fertilized using a water-soluble fertilizer every few weeks.
4. Be sure not to over water. Most flowering plants have a shallow root system. Watch for drooping heads, then water. For best results use a drip system, soaker hose or watering can.
5. Pinch off fading blooms. This will encourage and strengthen new growth. Let them die off naturally at end of season, this will bring you more plants next year.
