- **City of Tampa CPA 17-10: Future Land Use Map Change** - 3.00± acres (130,680± SF) located on water, north of Rocky Point Drive East, west of Post Apartment Homes, east of HCA (3031 North Rocky Point Drive West). Since this is water, there is no future land use designation. This request is for R-35 and is located in the Westshore Planning District.
- **City of Tampa CPA 17-11: Text Amendment** - Change to the R-10 and R-20 land use category matrix, regarding the number of dwelling units/net acre.
- **City of Tampa CPA 17-12: Future Land Use Map Change** - 1.74± acres located south of East Kennedy Boulevard and west of South Armenia Avenue. This request is located in the Palma Ceia Pines neighborhood and the Central Tampa Planning District. This request is from R-20 to R-35.

## Separating Your Debris

Debris should be placed curbside, without blocking the roadway or storm drains.

**NO PICKUP ZONE**  
Any debris placed from the sidewalk toward your property will not be picked up.

**DEBRIS SEPARATION**  
Separate debris into the six categories shown below.

**DO NOT STACK OR LEAN**  
Placing debris near or on trees, poles, or other structures makes removal difficult. This includes fire hydrants and meters.

**UNSURE WHERE TO PLACE DEBRIS?**  
If you don't have a sidewalk, ditch, or utility line in front of your house, place debris at the edge of your property before the curb.

**Normal Household Trash**  
Normal household trash and bagged debris of any kind will not be picked up with disaster debris. You should continue to follow your normal garbage removal schedule.

**VEGETATIVE DEBRIS**

- Leaves (do not put in bags)
- Logs
- Plants

## Tampa—Assistance Centers for Hurricane Irma

TAMPA — City Hall is opening four community assistance centers to help Tampa residents apply for Federal Emergency Management Agency aid and for limited local funding to help repair damage caused by Hurricane Irma. The city's Disaster Recovery Program will take applications until its funding is exhausted. The program will provide funds to help pay for up to \$10,000 of repairs to:

- Habitable homes with damaged windows, roofs, sewer lines or other threats to life and safety.**
- Residual damage such as leaking roofs. Dangerous situations such as exposed wires. Make homes habitable.**

The homes must be in the city of Tampa and cannot be mobile homes. They cannot be subject to overdue property taxes or judgments of any amount, although an exemption may be made for hospital expenses. Homeowners must have a FEMA registration ID number to apply for the city program. They also must have a home-stead exemption, be current on the mortgage and property taxes, cannot own more than one property, cannot have tax liens or bankruptcies and must meet certain income requirements.
