The deadline to submit your Tangible Personal Property Tax Return (DR-405) and the 30 day Extension is Friday, April 1. We are now accepting 2016 returns through the Tangible E-file System:

If you missed the March 1 deadline to file for a 2016 Exemption, Florida law allows our office to accept late applications. Late filers may file a late Homestead, personal exemption or portability application until early September.

This deadline will be 25 days after the mailing of the Notices of Proposed Property Taxes.
