Chapter 16

Non-profit organization (also *not-for-profit organization*) shall mean a corporation actively registered in any state as a non-profit charitable corporation, no part of the net earnings of which inures or may lawfully inure to the benefit of any private shareholder or individual, and which has been held to be tax exempt under the provisions of Section 501(c)(3), (4), (7), (10), or (19) of the Internal Revenue Code of 1954.
